#### **OFFICIAL RULES**

# I. NAME OF SPONSOR

KABC-TV, American Broadcasting Companies, Inc., ABC Holding Company Inc. (Hereinafter collectively referred to as "Sponsor").

# II. ELIGIBILITY

Viewers should watch ABC7 Eyewitness News at 11pm PT for "The Dallas Raines Weather Question and Answer of the Week" occurring each Friday (Fridays March 16, 23 & 30, and Fridays April 6, 13, & 20), during the Sweepstakes Period. Check local listings. Each Friday, there will be one multiple-choice weather-related question, followed by a commercial break, and then a return to the newscast with an announcement for the corresponding ANSWER for that week that will also appear on-screen once.

For example, if the ANSWER on Friday March 16, 2018 is "cat" the entrant has to submit the correctly spelled word "cat" (capitalization does not apply) no later than Tuesday March 20, 2018 at 10:00am PT. #### IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Every **Tuesday**, beginning **March 20**, **2018 through April 24**, **2018 (Tuesdays March 20 & 27**, **and Tuesdays April 3**, **10**, **17**, **& 24**) on or around 10am PT, one (1) potential secondary prize winner will be selected via a random drawing from among all eligible entries received for that week. The potential winner for that week will be announced during Eyewitness News at 11pm PT (barring breaking news), subject to confirmation of eligibility. Secondary prize winners, are ineligible for the grand prize.

The Grand Prize winner will be selected on Tuesday, April 24, 2018 at 10am PT at the conclusion of the Entry Period from all remaining eligible entries from every week during the Sweepstakes Period (i.e., all eligible entries from the Sweepstakes Period that were not selected as secondary prize winners). The Grand Prize winner will be announced on Friday, April 27, 2018 during the 11pm newscast.
